1. Welcome and Agenda

2. Student Fees for 2023 - 2024 – Katie Collier, Deputy Superintendent Learning presented the District Student Fees for 2023-2024.

Transportation, Facility Rental and Food Service Fees for 2022/23

Jason Gillam, Director of Business Operations provided an update on the Transportation and Facility Rental Fees for 2023-24. Student Transportation Fees are reviewed on an annual basis. Due to multiple years of contract cost increases, we are recommending a minimal change to the early pay rates (before July 1). The regular pay rates (after July 1) are not changing. Most registered pay riders sign up by the July 1 deadline. The recommendation for the roundtrip service for one student by the early pay deadline is to be \$335 in 2023-24 compared to \$315 in 2022-23. The other related fees for half day or additional siblings are recommended to change proportionately.

Facility Scheduling Fees are reviewed on an annual basis. After a current review, we have a number of minimal facility fee increases to better offset increased utility and consumable costs. Most space types that saw increases only went up a couple of dollars. Miscellaneous fees had one change with the reduction of field lights to \$30 which covers our costs and should promote more usage. All labor support fees increased to better align with recent pay raises. The facility fee changes are expected to generate approximately \$84,000 in additional revenue to offset expenses.

Charles Rathbun, Director of Food and Nutrition Services provided an update on recommended meal prices for the 2023-2024 school year. Upon current review, we are recommending not increasing student breakfast, lunch, and milk prices for the 2023-2024 school year. It is required to

increase adult breakfast and lunch prices \$.10 since these meals can't be subsidized by the National School Breakfast and Lunch program. Based on the Food and Nutrition current financial position it is recommended to spend down some of the department's reserve and not increase costs to Blue Valley families. Food and Nutrition Services will continue to closely manage operating expenses and evaluate the department's financial position next school year.
