CURRICULUM

Savvas Learning Company – This purchase provides print and digital access for students and teachers for the Astronomy course at high school. This is a 7-year adoption. (Learning Resources \$86,861.20 Estimated)

Savvas Learning Company – This purchase is for a 7-year adoption for on-level Physics. It contains student and teacher resources, both print and digital. (Learning Resources \$45,522.00 Estimated)

Seesaw Learning Inc. – This purchase is for virtual curriculum to use with our elementary students to support a resource that has been used with their free version. It provides additional digital

enhanced learning activities for students needed to further support distance learning and virtual learning. Year 3 of 3. (Capital Outlay \$52,552.50)

CONTRACTS

All Point Transportation, LLC – Originally reported in February 2023. Year 3 of 3 year agreement. All Point Transportation LLC provides van or sedan transportation for our students. This contract is primarily used for transportation for our 18-21 year old Special Needs students, some out of District McKinney Vento students and other students as determined by the District's Transportation Department.
