

FINANCE & OPERATIONS BOARD ADVISORY COMMITTEE MEETING MINUTES

Date: March 28, 2024 Time: 7:30 a.m. Place: Board of Education Room

The Finance & Operations Advisory Committee met on March 28th in the District Office Board Room. Dave Arteberry with Stifel Nicholas reviewed a potential bond refunding opportunity for the District for the 2015-AB bonds. If market interest rates do not materially increase, the 2024-A refunding bonds would be sold in June. District administration reviewed the proposed meal prices, transportation fees, facility rental fees, and academic fee schedules for 2024-25. Bids and Contracts were reviewed by the Operations Department, with input from the Academic Services Department for Curriculum related purchases. The next Finance & Operations Committee meeting is scheduled for May 9th in the District Office Board Room.

Amplify Education, Inc. – This purchase includes teacher editions and digital access for middle school ELA teachers for 7 years. The teacher digital access includes assessments, reteaching and extension materials including grammar and morphology, a robust data dashboard with support for personalizing instruction, the teacher manual in digital form and presentation files for instructional support. There are also embedded features to support English Language Learners. For students, the purchase includes consumable student textbooks and writing journals replenished annually for the length of the adoption. Students will also have digital access to the resource with embedded supports and scaffolds, opportunities for formative assessment and exit tickets, interactive learning experiences and robust amount of literature. (Learning Resource)

College Board - This is for Advanced Placement Testing which is paid for by parents through activity accounts. Estimated number of testers for 24-25 is based off of the number of testers over past years. NOTE: The cost is \$108/test and is divided as follows – \$88/test to College Board (tests cost \$97 each, but schools get a \$9 rebate per test), Total Registration collects \$1.86/test, we keep the rest to help with test administration. [The biggest cost for schools is hiring proctors to administer exams, who we pay \$20/hour.] Additionally, it is possible that College Board increases the cost per test. They make those decisions each summer. (Activity Funds)

[NOTE: The price is subject to change, College Board reviews prices in the summer.] (Activity Funds)

[NOTE: The quote is from Illuminate education from a couple of years ago as that still governs our agreement, however, Illuminate has since been bought out by Renaissance.
