

Dear Mustangs,

Below please find the details for student parking for the 2022-23 school year.

### **PARKING LOTS & STUDENT PARKING**

- Students will not have a specific reserved parking spot.
- There will be a student parking lot for seniors, juniors and sophomores who are 16 and who have purchased a permit and have their pass displayed.
  - BVN parking lot map is attached.
- We will sell 659 permits for parking for the 2022-23 school year, the number of student spots available in the BVN lot.
- Sophomores can purchase a permit when they turn 16 by visiting the Safety and Security office, as long as permits are still available. Sophomore parking permits will not be available for purchase until Monday, August 30<sup>th</sup>.
- Freshmen are **NOT ALLOWED** to park in the BVN parking lot and will NOT be issued a parking pass.
- Any car parked in student parking without a displayed permit is subject to a fine, this includes parking in overflow. BVN students who park in the Staff Lot or Visitor Lot will also be ticketed.

### **PERMIT INFORMATION**

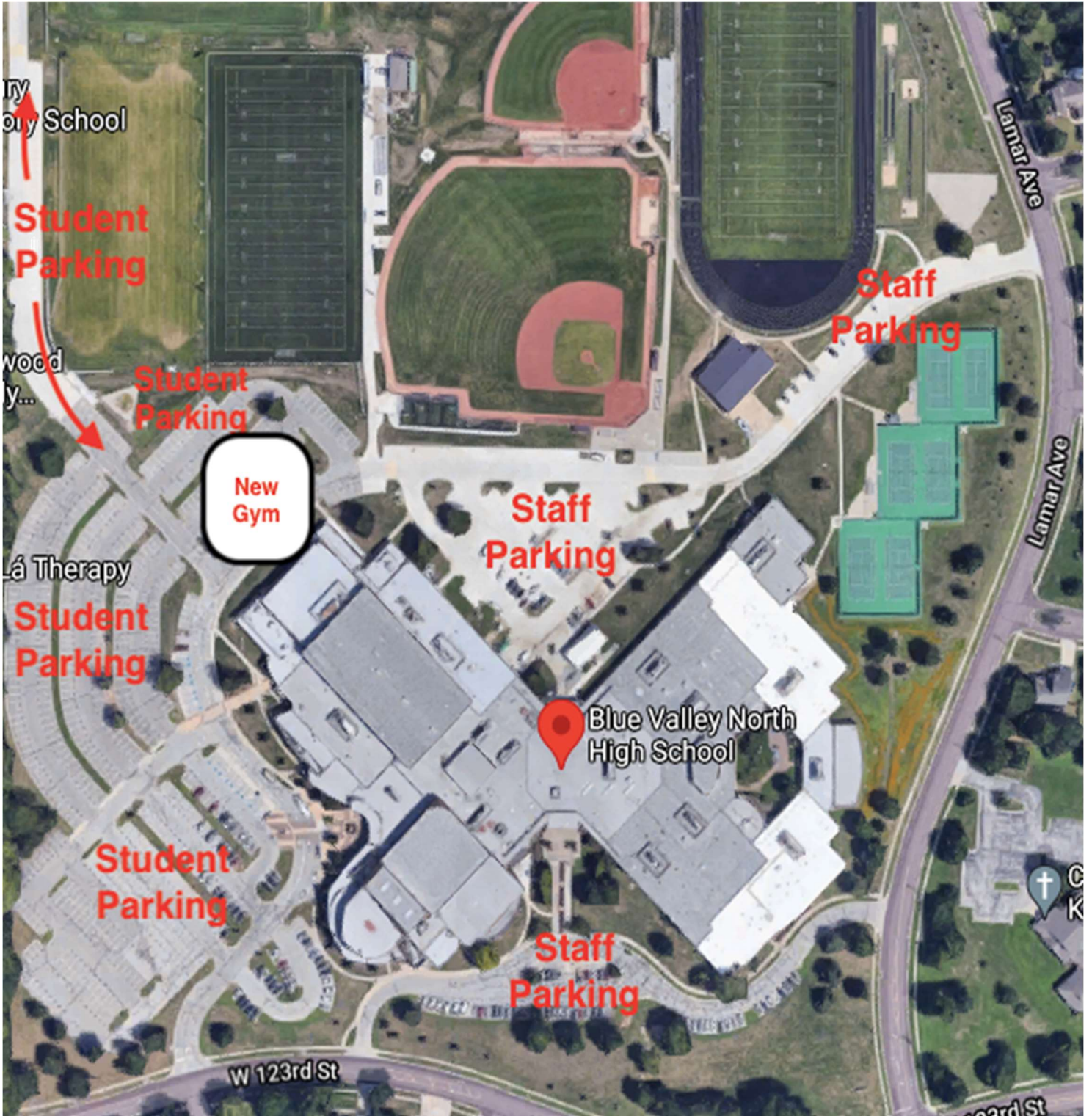
- Permits can be purchased through ParentVue during registration
- Permits will not be issued if a student has an outstanding balance from the 2022-23 school year or has not paid for their 2022-23 permit.
- All students who purchase a permit are required to sign the BVN Parking Agreement (attached) before a permit is issued to them. **PLEASE BRING THIS COMPLETED FORM WHEN YOU PICK UP YOUR PERMIT.**
- Permit Pickup:
  - Monday, August 8<sup>th</sup>, 8:00-11:00 a.m.
  - Tuesday, August 9<sup>th</sup>, 12:00-3:00 p.m.
  - Wednesday, August 10<sup>th</sup>, 8:00-11:00 a.m.
  - Thursday, August 11<sup>th</sup>, 12:00-3:00 p.m.
  - Additional permit pickup will be available during student lunch periods August 22-26.
  - **ALL JUNIORS AND SENIORS WHO PURCHASE A PERMIT BEFORE SCHOOL WILL GET A PERMIT. THEREFORE, IT IS NOT NECESSARY FOR ALL STUDENTS TO SHOW UP ON THE FIRST DATE/TIME FOR PERMIT PICKUP.** There are no reserved spots and we have plenty of permits for students. Please understand if everyone visits BVN on the first permit pickup time/date, you should be prepared to wait.
  - Permit pickup will take place at the BVN Safety and Security Office

1. The parking permit fee is **\$35.00** per student for each school year.
2. A separate registration form should be submitted for each vehicle a student may drive to school.
3. Students must present a valid driver's license in order to receive a parking permit.
4. Student vehicles must be legally registered and properly insured.
5. Parking permits are not transferable to other persons.
6. Parking permits must be visibly displayed in student vehicles on campus.
7. Student vehicles will be parked only within the marked spaces in the designated student lots. Student vehicles are not to be parked in reserved, visitor or staff spaces.
8. State issued handicap license plates or permits must be displayed on vehicles parked in handicap spaces.
9. Students assume full responsibility for their vehicle, its content and operation, while on school property; Blue Valley School District is not responsible for thefts, damage, injury, or accidents.
10. Loitering in parking lots is prohibited. Students are expected to enter the school directly upon arrival and depart promptly upon dismissal.
11. The speed limit on campus is 15 mph for all drivers unless otherwise posted.
12. Illegal drugs, alcohol, cigarettes, and weapons are prohibited on school premises. Students may not store any of these items in their vehicle while on school property.
13. All student vehicles on Blue Valley School District properties are subject to search based upon reasonable suspicion.
14. All parking fines are \$25.00 per violation. Parking permits may be revoked if fines are not paid to the school bookkeeper within ten days of issuance. Permits will not be issued to students with outstanding parking fines.

At BVN: 11<sup>th</sup> and 12<sup>th</sup> grade students are eligible to apply for a parking permit, 10<sup>th</sup> grade students are eligible if 16 years old, possess a valid driver's license, and space is available. Permits for 10<sup>th</sup> graders who are 16 will be available on Monday, August 23<sup>rd</sup>.

Due to limited parking space at some facilities, the school district reserves the right to restrict the number of parking permits issued.
