***Ender's Game* by Orson Scott Card**

WHAT'S THE STORY?

It is 2070, forty years since a devastating alien invasion was barely turned back, and the world is desperately searching for soldiers to lead them to victory when the “Buggers” (aliens) return. To save earth, the world government drafts young children to pass a rigorous screening; after sending them to Battle School, they graduate having been trained in the technology of warfare. Six-year-old Andrew Ender Wiggin heads the class in his ability to cope with the technology and strategies to defeat the invaders. Conflict arises externally as a peer and a teacher vie for leadership among the combatants. Internally he battles to not become the same as the alien foes who are monsters. In the end his decent human instincts win, and the world is saved.
